**ORDER:**

Whereas, the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30 of 2013) has been enacted by the Parliament and published by Government of India in the Gazette of India 1<sup>st</sup> read above.

2. And whereas, the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 has been brought into force w.e.f.1<sup>st</sup> January, 2014 vide Notification 2<sup>nd</sup> read above.

3. And whereas, the Chief Commissioner of Land Acquisition & Special Chief Secretary, Andhra Pradesh, Hyderabad has submitted the proposal for appointing Joint Collector as Administrator under Section 43 (1) of the Act (No 30 of 2013) in the letter 3<sup>rd</sup> read above.

4. Government after careful examination of the said proposal hereby issue the following notification appointing the Joint Collector and Additional District Magistrate as 'Administrator' under sub-section (1) of section 43 of the said Act. Accordingly, the following notification shall be published in the Andhra Pradesh Extraordinary issue of Andhra Pradesh Gazette, dated 01-01-2015.

**NOTIFICATION**

In exercise of the powers conferred under sub section (1) of section 43 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (i.e.30 of 2013) the Government hereby appoints the Joint Collector and Additional District Magistrate as "Administrator" for LARR Projects in their respective jurisdiction and shall exercise all the powers conferred and discharge all the duties imposed on the Administrator under the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

(2) The Administrator shall work under the Supervision, direction and control of Government and the Commissioner for Rehabilitation and Resettlement. The responsibility for formulation, execution and monitoring of the Rehabilitation and Resettlement Scheme shall vest with the Administrator.

(3) All the Rehabilitation and Resettlement Awards under sub-section (1) of section 31 shall be approved by the Joint Collector / Administrator before being approved by Commissioner, Rehabilitation and Resettlement and pronounced by Land Acquisition, Rehabilitation and Resettlement Officer i.e., Collector under the Act.
